

Acoustic Delight Synchronization and Master License - Agreement

This is an agreement between Gregory P Gardner (the "Licensor") creator of the Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 and _____ (the "Licensee") of _____.

By purchasing the Synchronization and Master license you agree to be bound by the following terms and conditions (the "Agreement").

1: Non Exclusive License.

By purchasing the Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 Synchronization and Master license, the Licensor grants the Licensee the limited, non-exclusive, non-transferable, worldwide right and license to use the Acoustic Delight recordings listed in the appendix (Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 - Audio Tracks) in accordance with the terms and conditions of this Synchronization and Master License agreement.

In consideration of the license purchase, the Licensee hereby agrees to pay the Licensor a \$US49 license fee.

2: Usage. You may:

(a) Use the Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 recordings an unlimited number of times for your personal projects and or professional/commercial projects for any & all media now known or hereafter devised throughout the world in perpetuity.

(b) Sell, license, make available for download and steaming the finished tracks, products or productions with Acoustic Delight Sample, Loop & Song Phrases & Library Vol. 1 recordings synchronized and embedded as soundtracks, background music or as audio logos. Or incorporated into song compositions, instrumentals or derivatives.

(c) This license does include public performance rights. You agree to report the licensor (Gregory P Gardner) of Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 recordings as a percentage as co-writer when used in Film, TV, radio productions and live performance to the appropriate Performing Rights Association or TV station, Radio Station, Network. Either by completing and submitting a Cue sheet or live performance return. Or by downloading an Acoustic Delight Cue sheet from the Acoustic Delight web site to be completed and returned to Acoustic Delight by email.

(d) Sell, market, promote or make available the Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 recordings as a part of your music composition or as a derivative work.

3: Limitations. You may not:

(a) Claim to be the creator or copyright holder of the Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 recordings.

(b) Sublicense, give away or in any way assign the Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 recordings or your rights granted hereunder to any other party.

(c) Resell or make the Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 recordings available or downloadable as separate audio files to a third party.

(d) Use Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 recordings for the creation of sample or loops pack.

(e) Make a copyright claim against any other licensee of Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 recordings for their use of the Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 recordings.

4: Ownership.

(a) You hereby acknowledge that the Licensor is and remains 100% owner of all rights, titles and interests in the Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 recordings, including without limitation any copyrights therein.

(b) Agree to credit the licensor (Gregory P Gardner) as a co-writer by percentage of use in any musical work using the Acoustic Delight Sample, Loop Song & Phrases Library Vol. 1 recordings.

The Acoustic Delight Sample, Loop Song & Phrases Library Vol. 1 recordings are protected by and subject to Australian and international copyright laws. This license is non-exclusive and the Licensor retains the right to sell licenses of the Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 recordings to other parties at his sole discretion.

5: Warranty.

The Licensor warrants and represents that all recordings in the Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 are written and composed by the Licensor and hereunder be 100% owned by the Licensor.

6: Limitation of Liability.

The Licensor makes no warranty or representation, express or implied, except that the Licensor warrants that he has the right to grant the license granted hereunder. The total liability of the Licensor under this Agreement arising from the Licensees use of any Acoustic Delight Sample, Loop & Song Phrases Library Vol. 1 recordings shall be limited to the license fee paid by the Licensee for such recordings. The Licensee hereby agrees that this license is granted without any other recourse.

7: General Provisions.

This Agreement shall be governed according to International copyright law and the laws of the Commonwealth of Australia. If any provisions of this Agreement be invalidated for any reason such invalidation shall have no effect on the remainder of this Agreement and the Agreement shall remain in full force and effect.

8: Taxes.

The license fee charged by the Licensor does not include any taxes, duties or other government charges. It is the responsibility of the Licensee/purchaser to comply with the tax laws of their own country.
